02. The transfer of above mentioned SSS officers are on their “own requests”, however, as per clause 4.2 of Transfer & Placement Policy of SSS dated 21.08.2024, those SSS officers who have completed 04(four) years or more at present place of posting (*from date of joining at present place of posting to till date of issuance of this order*) shall be entitled for joining time/TA/DA etc. as per extant rules.

03. Further, the period mentioned against the below mentioned officers be treated as compulsory wait in the SSS Cadre and the salary & other allowances for the said period shall be paid by their respective new offices after due verification from LPC.
