ORDER

Subject: Grant of Modified Assured Career Progression (MACP) to SI Grade I of SSS.

In pursuance of DOP&T's guidelines on MACPs and on the recommendation of the Screening Committee, meeting of which was held on 15th July 2012, the Competent Authority has approved grant of 2nd and 3rd MACP in Grade Pay of Rs. 4800 in Pay Band -2, on personal basis, to **Statistical Investigator Grade I** of Subordinate Statistical Service (SSS) who have stagnated in the same post for more than 10 years in the scale of Rs. 6500 – 10500 ignoring the up-gradation granted to them on non functional basis in the pay scale of Rs. 7450 -11500 on or after 01.09.2008 as per details given below:

2. The officers are entitled for fixation of pay as per the provisions of CCS (Revised Pay) Rules, 2008 and the MACP guidelines. However, they shall not get any additional increment on being promoted on Ad-hoc basis as Assistant Director (JTS of ISS) and only the difference in the Grade Pay (i.e. Rs. 5400 – 4800 = Rs. 600) w.e.f. date of promotion may be added to their pay in terms of Para - 4 of Annexure – I of MACP Scheme of DOP&T dated 19th May 2009.

3. The Participating Ministries / Department / Organization of SSS are requested to see that officer placed in the higher Grade Pay under MACP, is not under suspension or no charge sheet has been issued or no disciplinary proceeding or prosecution case for criminal charge is pending against him.

4. The officer, if any, who is under currency of penalty, will be placed in the next higher Grade Pay only on expiry of that period.

5. The Participating Ministries / Department / Organization of SSS is requested to provide copy of this order to all concerned incumbents and place a copy of the same in service book of officials..
