2. Keeping in view large number of vacancies of S.I. Gr. II in NSSO (FOD) in North- Eastern States, the officials posted from offices located in N-E States (Sl. No.13, 14, 17, 18, 20, 21, 22 and 24) have been promoted on In-situ basis at the same stations.

3. Officers promoted as S.I. Gr. I vide MOS&PI OM dated 20.06.2013 cited in para 1 above, having Less than one year of service (Sl. No. 3, 4 and 8) have been posted on In-situ basis at the same station.

4. The officers retained at the same stations on in-situ basis will not have any right to continue in same office/station at the time of their regular promotions.

5. The promotions will be effective from the date of assumption of charge of the new post and till further orders. It is also stated that ad-hoc promotions are being made purely as a temporary measure and as a stop-gap arrangement and can be withdrawn/cancelled at any time without assigning any reasons. The promotion will not bestow on the above mentioned officers any claim for regular appointment and ad-hoc service will not be counted for the purpose of seniority in that grade and for eligibility for promotion etc.

6. Persons who have been posted at new stations shall have to move to the new places immediately, failing which it would be treated as refusal of promotion.
