Reference is invited to this Ministry OM No. 12039 / 01 / 2009 (Part) [MACP-2] dated 30.08.2016 vide which 42 MACP cases of SSS were deferred for want of APARs and this position was also brought into the notice of all concerned offices. However, APARs of concerned officers have not been received till date.

O2. As per Schedule attached with DOP&T OM No. 21011 / 02 / 2009 - Estt. (A) dated dated 16th February 2009, it was directed to All Ministries to strictly follow prescribed time schedule at various stages in the matter of APAR of all classes of employees for smooth consideration of Promotion, MACP, Confirmation, Deputation to ex-cadre posts etc. Accordingly, this Ministry had directed All Divisional Heads vide this Ministry OM No. A-46030 / 26 / 2015 - Ad. I dated 07.10.2015 and OM No. 12011 / 02 / 2015 - APAR dated 31.08.2016 to strictly follow time schedules of the APAR as prescribed by DOP&T, so that the complete APARs in all respects may reach APARs cell of MoSPI. However, it has been noticed that these instructions of DoP&T and MoSPI are not being followed in true letter and spirit. Despite repeated instructions, APARs of the following officers of SSS, of the years as mentioned against their names, have not yet been received in the Ministry.

- As per instruction of DoPT dated 19.05.2009, the Screening Committee would follow a time-schedule and meet twice in a financial year - preferably in the first week of January and first week of July of a year for advance processing of the MACP cases maturing in that halfs. Accordingly, cases maturing during the period of October 2016- March-2017 were required to be considered by the Screening Committee Meeting in the first week of July of 2016.
- As per instructions of DOP&T, it is the responsibility of concerned officer(s) to follow the instructions strictly in the matter of APAR but the same has not been complied with. Non-compliance of the instructions of DOP&T as well as that of this Ministry may attract disciplinary or administrative action against the guilty officer(s).
- All concerned Administrative Ministries and officers are once again requested to furnish relevant APARs of the above mentioned officers immediately, without any further delay, so that their MACP cases may be settled.
- Copy of above OM may also be provided to the concerned officials, with proper acknowledgment, under intimation to this Ministry.
