02. The Participating Ministries / Departments / Organizations of SSS are requested to fix the pay of incumbents working under their administrative control in the higher Pay Scale after <u>due verification of eligibility conditions of ACP</u> from the service records of the officers.

- **03.** The Participating Ministries / Departments / Organizations of SSS are further requested to ensure that the officer placed in the higher Pay Scale under ACP, is not under suspension; no charge sheet was issued; no disciplinary proceeding or prosecution case for criminal charge was pending against him on the crucial date of ACP.
- **04.** The officer, who is under currency of penalty, if any, will be granted financial up-gradation as per ACP Scheme only on expiry of that period.
- **05.** On account of grant of 2nd ACP in the pay scale of Rs.8000-13500 (GP of Rs.5400, PB-3), promotions from Statistical Investigator Grade II (Rs.6500-10500) to Statistical Investigator Grade I (Rs.7450-11500) [NFG], if any, during the period of 01.01.2006 to 31.08.2008 became infructuous and the same may be treated as redundant. Thus, pay fixation would be made directly from Rs.6500-10500 to 8000-13500 (GP of Rs.5400, PB-3) before introduction of MACP Scheme. Intermediate pay fixation in the pay scale of Rs.7450-11500 may not be taken into account at the time of fixation under 2nd ACP.
- **06.** All participating Ministries of SSS is clarified that before extending the benefit of 2nd ACP in the pay scale of Rs.8000-13500 (GP of Rs.5400, PB-3), the instructions relating pay fixation under arbitration award of Rs.75/-, issued by this Ministry from time to time may also be followed strictly and applied uniformly, so that excess payment, if any, may be adjusted before releasing the arrears.
- **07.** The Participating Ministries / Departments / Organizations of SSS are requested to extend the financial benefits under the provisions of ACP Scheme dated 09.08.1999 after due verification of the date of ACP from their service book with all consequential benefits under intimation to this Ministry.
