#### Office Memorandum

Sub: Re-induction of Investigator Grade II of Labour Bureau in Subordinate Statistical Service (SSS)- Regarding.

Pursuant to the directions of Hon'ble High Court of Delhi in RP No. 84 / 2018 dated 16.03.2018, the issue relating to re-induction of Investigator Grade II of Labour Bureau has been considered in the light of judgment of Hon'ble High Court of Delhi in WP No. 8437 / 2015 [Hans Raj & ORS Vs. UOI] dated 13.11.2017.

- **02.** As per the order dated 16.03.2018 of Hon'ble High Court of Delhi, the petitioners are required to furnish their option for re-induction into Subordinate Statistical Service (SSS) within two weeks from the date of the said order. However, petitioners have not furnished their option in the prescribed format for re-induction into SSS earlier provided to them on the pretext that "option forms dated 04.12.2014 and 24.07.2017 does not contain the observations made by Hon'ble High Court of Delhi order dated 16.03.2018".
- **03.** It is clarified that the issue relating to pay fixation had already been clarified to the petitioners vide this Ministry OM No. 12039 / 03 / 2014 SSS dated 5th April 2016 and subsequent OM of even number dated 26th April 2016. The petitioners were also given another opportunity to furnish their revised option vide OM of even number dated 24.07.2017. However, they had not submitted the requisite option in the prescribed format in the stipulated time limit.
- **04.** The petitioners were earlier de-cadred and repatriated since the RRs of SSS dated 12.02.2002 (Group C) did not permit their absorption in the pay scale of Rs.5500-9000 (Pre-revised Rs.1400-2300 in 4th CPC, and GP Rs.4200, PB-2) and their absorption in the pay scale of Rs.5000-8000 (Group C), GP of Rs.4200 had become infructuous. However, the concerned incumbents are hereby given one more opportunity to exercise their option for re-induction in Subordinate Statistical Service (SSS) on the basis of existing RRs dated 31.05.2013 as Junior Statistical Officer (JSO) (Rs.5000 8000, Group C, GP of Rs.4200 in 6th CPC and Level 6 in 7th CPC), if they so desire. Those who opt for re-induction in SSS, shall furnish an unconditional option as per the enclosed proforma [Attached as Annex-I], so that they may be considered for re-induction in SSS as per the existing instructions of DoPT on the date absorption. After receipt of option, the process of re-induction in SSS would be initiated in consultation with DoPT, MoF and MoLE & DoLA.
- **05.** Ministry of Labour & Employment (MoLE), is requested to provide the option form to the concerned incumbents, as per the list enclosed [Attached as Annex- II], with the request to exercise their option within 20 days, if they so desire. If this Ministry does not

receive the unconditional option within 20 days from the date of issue of this OM, it will be presumed that the concerned incumbents are not willing to be re-inducted into SSS.
