#### Sub: Tender for "Hiring of Vehicle on contract basis for Official Purpose"

With reference to our tender notice for Hiring of cars on contract basis, sealed quotations are invited from reputed Registered Transport Operators/ Taxi Car Operators having a valid permit issued by the Regional Transport Authority for hiring of AC 4 seated sedan type car on monthly rental basis for one year from the date acceptance of following terms and conditions.

The quotations are to be submitted in two parts i.e., Technical Bid and Financial Bid in separate sealed envelopes contained in a single big envelope. The sealed cover should be marked on the top as "Quotation for Hiring of Vehicle" (*Tender Notice No.* 7/5/2011/Car/Admn.III dated 03.05.2016)

Intended bidders are requested to quote their rates in respect of the above mentioned car to be supplied to this office subject to the fulfillment of the terms and conditions mentioned below:-

- 1. The vehicle should be dedicated to the Department and should be of latest model and shall have clean seat cover/towels and in good running condition. The vehicle should be properly and comprehensively insured and should be not older than 2014 Model.
- 2. The firm should have at least three years experience in tour and travel and should not be blacklisted by any Government Department/Ministry.

- 3. Rate for supply of the vehicle will be binding on the bidder for a period of one year from the date of agreement. If the contract period is extended for further period of one year depending upon satisfactory performance, old rate will prevail on the same terms and conditions based on mutual agreement.
- 4. An Earnest Money of Rs. 25000/- in the form of Demand Draft/Pay Order in favour of Pay & Accounts Office, Ministry of Statistics & Programme Implementation, Kolkata is to be submitted along with the tender. Earnest Money received from the tenderers will be refunded without interest immediately after the process of award of the contract is over.
- 5. The fixed monthly rental charge quoted by the bidder will be inclusive of all taxes including the service tax. This rate will be inclusive of all consumables, fuel and lubricants etc.
- 6. The vehicle hired on regular basis are expected **normally** to report for duty at pick-up point at 08:30 A.M. and release of vehicle at 08:30 P.M. on Monday to Friday and may be required to report for duty any time during Saturdays, Sundays and closed Holidays subject to 2400 Kms/ / 320 hrs/31 days in a month.
- 7. Duty Hours will be calculated from "reporting time to the user" to "releasing time to the user". Additional Charges beyond 320 hrs in a month will be paid to the selected bidder as per rates quoted in the financial bid.
- 8. Daily distance in Kms will be first calculated from "reporting point to the user" to "releasing point to the user" and to this will be added 'garage to garage' distance daily subject to a maximum of 10 kilometers both ways. If the total distance calculated in this manner exceeds 2400 kms in a month, additional charges will be paid to the selected bidder as per rates quoted in the financial bid.
- 9. In case the vehicle runs more than 2400 Kms in a month and also total duty hours exceeds 320 hrs in a month, additional charges whichever is convenient to him will be paid to the selected bidder.
- 10. Any problem/defects notified by this office must be attended within 24 hours, failing which 10% of hiring charges will be deducted from monthly bills for the subsequent days till the defects are rectified.
- 11. Car should always be in good condition and periodical servicing of the car will be carried out by the bidder for avoiding any break down owing to any technical snag during the duty hours.
- 12. If the car happens to be out of order by any event or occurrence, the concerned firm should make immediate arrangement of another car of similar type and facilities instantly and ensure that the officers travelling by the car are not stranded or distressed on the road.
- 13. Photocopies of Income Tax clearance certificates against the supplied car are required to be submitted along with the quotation.
- 14. In case the Officer with whom the vehicle is deployed is on leave/ tour, the vehicle will report for duty in the office. No leave shall be allowed to the driver for such period.

- 15. The owner has to engage the driver for the car. Apart from driving, it will be the onus of the driver to clean the car regularly. Besides, the driver has to be good mannered and well trained and neatly dressed having at least 5 years of driving experience. Supporting documents are required to be attached. Changes of driver, if any, shall be made only with the prior approval of this office.
- 16. Supplied vehicle must be pollution free and a recent certificate in this regard must be attached.
- 17. Log Book of vehicles duly signed by the user should be maintained by the vendor and furnished at the time of submission of bill.
- 18. All types of repairing charges by the way of road tax, service tax, payment to the driver will be borne by the owner /supplier of the car.
- 19. Any type of additional charges by the way of road tax, service tax, payment to the driver will be borne by the owner/supplier of the car.
- 20. Payment will be made on monthly basis on production of bill in triplicate along with duty slip & log book.
- 21. Tax at source will be deducted from each bill of the vendor as applicable under rules in respect of Income Tax Act etc.
- 22. The contract is liable to be terminated at any time with a notice of 15 days and without assigning any reason to the bidder.
- 23. The firms willing to supply the car may quote rate in their respected company pad in a sealed envelope superscripting "**Quotation for Hiring Vehicle**" addressed to the Under Secretary, Central Statistics Office (Industrial Statistics Wing), 1-Council House Street, Kolkata:700 001.
- 24. Quotations may be dropped in Receipt & Issue Section of this office up to 15.00 hrs on *or before* **26.05.2016** and will be opened on the next working day i.e. **27.05.2016** at 3.00 pm, in presence of the bidders or their authorized representatives.
- 25. Incomplete quotations will be rejected outright.
