**CORRIGENDUM-I**

**No. A-12026/7/2018-E.II/Centre**

During the pre-bid meeting with the prospective bidders, the TTEC has noted following observations in the RFP document:

- The financial statements of the year 2017-18 are available with all the bidders, thus for getting the latest financial information from the bidders it was decided that the financial years for which turnover/profitability/IT returns, asked from the bidders in their technical bids, shall be changed to (2015-16, 2016-17, and 2017-18). Similarly, the credentials (work orders, contracts) which are asked from the bidders shall be of the latest three years thus it was decided that such credentials shall now be accepted and evaluated for last three years i.e. (2015-16, 2016-17, and 2017-18).
- Some typographic mistakes were observed in the RFP which also require updation/rectification.
- In order to elucidate it to all the prospective bidders, some clauses/sections of the RFP requires to be reformed.

Thus, the following clauses/sections in the RFP document may be read as follows:


