During the pre-bid meeting with the prospective bidders, the TTEC has noted following observations in the RFP document:



Similarly, the credentials (work orders, contracts) which are asked from the bidders shall be of the latest three years thus it was decided that such credentials shall now be accepted and evaluated for last three years i.e. (2015-16, 2016-17, and 2017-18).
- Some typographic mistakes were observed in the RFP which also requireupdation/rectification.
- In order to elucidate it to all the prospective bidders, some clauses/sections of the RFP requires to be reformed.
