Terms and Conditions Agreement

1. The contract of hiring of tablets is being entered by National Statistical Office (DQAD), Data Processing Centre, Ahmedabad hereafter referred as NSO(DQAD), DPC, Ahmedabad with (Vendor Name _____) hereafter referred to as Vendor on the (date) at NSO(DQAD), DPC, Ahmedabad.
2. The tablets will be supplied as per the specifications given in Annexure-I.
3. The tablets will be supplied within 5 days from award of contract.
4. The tablets may be replaced by vendor, if they are not found in working condition at the time of delivery. Replacement should be done within 2 to 3 days without any additional charges.
5. Configuration must be checked at the time of delivery, if any mismatch found, the tablets should be replaced within 2-3 days without any additional charges.
6. Initially the contract will be for 6 months period (from the date of signing of this Agreement by the parties), which may be extended if required subject to satisfactory services, on discretions of NSO(DQAD), DPC, Ahmedabad.
7. This Office reserves the right to increase or decrease the quantity or delete some or all of the items, depending on the needs of the office without assigning any reasons.
8. During the hiring period if the tablets becomes non/partial functional due to technical fault, same shall be replaced within 2-3 days without any additional charge.
9. Vendor shall give in writing the specifications of the tablets. The tablet should be enabled with 4G sim slot for internet connectivity.
10. The rate quoted will remain in force for the full period of the contract. No demand for revision of rate on any account shall be entertained during the contract period.
11. The charges/rent of contract will be payable on quarterly basis after satisfactory completion of each quarterly service.
12. In case the vendor is not able to repair/provide service to any of the tablets within the stipulated time the item will be got repaired/serviced from open market and repairing/servicing charges will be deducted from the payment for the quarter from vendor.
13. In case the service is not found satisfactory, NSO(DQAD), DPC, Ahmedabad can terminate the contract by giving a notice of two weeks and the payment for the past service rendered shall be made on proportionate basis.
14. Payment will be subject to Govt. of India rules and regulations and will not be hard-cash form.
15. ARBITRATION CLAUSE: In case of any disputes between the parties viz. the Office on one hand and the agency/firm awarded the Contract on the other

hand, arising out on account of scope of the work and other mandatory liabilities as stated in the Tender Document/Contract Agreement, the dispute shall be referred to an Arbitrator as per Arbitration and Reconciliation Act, 1996, in Ahmedabad jurisdiction.

16. The Office reserves the right to accept or reject any or all the offers without assigning any reason.
17. The successful bidder will enter into a contract with NSO(DQAD), DPC, Ahmedabad.
18. Documents to be submitted by the Vendor/agency:
 - a. Registration certificate issued by appropriate authority.

 - c. An undertaking that the agency has not been blacklisted by any Government Department/Autonomous bodies.
