TERMS AND CONDITIONS OF AGREEMENT

- 1. The comprehensive Annual maintenance Contract (AMC) is being entered by National Sample Survey Office, DPC Nagpur hereafter referred to as NSSO, DPC, Nagpur with Name..... hereafter referred to as Vendor on the (date).....at NSSO, DPC, Nagpur.
- 2. Comprehensive maintenance of Computers, laptops, printers, and servers installed in NSSO, DPC, Nagpur. The list of items covered under AMC are given in Annexure-I.
- 3. Initially the contract will be for ONE-Year (from the date of signing of this Agreement by the Parties), which may be extended for one more year subject to satisfactory services, on discretion of NSSO, DPC, Nagpur.
- 4. The rate quoted will remain in force for the full period of the contract. No demand for revision of rate on any account shall be entertained during the contract period.
- 5. Maintenance Services shall be provided immediately on the same day during 09.30 am to 06.00 pm at office DPC, Nagpur whenever called upon.
- 6. Call must be attended within 1 hour.
- 7. 5% penalty will be levied per machine per day after 48 hours of down time.8. The NSSO, DPC, Nagpur shall not liable to make payment over and above the maintenance cost in any case.
- 9. All Computers with internet connection or without Internet connection should be virus free during AMC Period.
- 10. Quarterly payment will be made after satisfactory service.
