## SHORT TENDER NOTICE

- 2. The Risograph (EZ 3700) is presently in good working condition and under AMC. Interested bidders may inspect the machine during office hours from Monday to Friday (excluding holidays) at the premises of the Ministry before rates are quoted.
- 3. Sealed tenders/ quotations should be submitted to the undersigned latest by 3.00 PM on 25.09.2015 at the address "The Under Secretary (Genl.), Ministry of Statistics & PI, Room No. 201, Sardar Patel Bhawan, Sansad Marg, New Delhi-110001." The bids will be submitted in the separate envelops in sealed cover containing (technical and Financial) and placed in another envelop. The words "Tenders for the AMC of Risograph (EZ-3700)" may be superscribed and must be dropped in the Tender box kept at Ground floor of Sardar Patel Bhawan, New Delhi. The Technical bids will be opened at 3.30 PM on the same day and the representative of the firm may be present, if so desire.
- 4. The terms & conditions of the contract for the Risograph (EZ-3700) Machine is as under :-
- a. The firm should also have sufficient experience of atleast 3 years of doing aforementioned maintenance job in the Government Department/ Ministries.
- b. The form should also have Registration/ PAN/ Service Tax Numbers etc.
- c. The firm will also maintain a call register and submit service report to this Ministry before release of the payment.
- d. The repair work of the Machines are to be carried out in the premises of this Department and no relaxation would be given to take out any part/machines outside the premises for repairing etc.
- e. The company will submit the estimate for replacement of parts( which are not covered under AMC) on receipt of a written letter.

- f. The complaint should be attended promptly on receipt of telephone call from the Ministry including on holidays( especially during parliament session).
- g. The quotation should be accompanied by earnest money of Rs. 5,000/(five thousand only) through a demand draft on any scheduled bank in
  Delhi / New Delhi drawn in favour of Pay & Accounts Officer, Ministry of
  Statistics & PI New Delhi. The earnest money received from the tenderers
  will be returned without interest immediately after the process of
  selecting the awardee is over.

h. The contract can be terminated by the Department at any time without assigning any reason, if the work of the firm is found to be unsatisfactory, and it would be entrusted to any other party at the risk and expenses of the defaulting firm. In this connection, decision of the Department shall be

final and binding upon the contractor.

i. The successful bidder will have to furnish a performance Security Deposit of Rs.10,000/- (Rs. Ten thousand only) within 7 days from the date of giving intimation to him for acceptance of his tender. The Security deposit shall be in the form of Demand Draft favoring Pay & Accounts

Officer, Ministry of Statistics & PI., New Delhi.

j. The Security deposit will be refundable after the expiry of the contract period successfully and to the satisfaction of the competent authority. The Government has the right to forfeit the security money, in case of non-cooperation, disobedience of the instructions, non-attending of the complaint within time or due to any damage of equipment on the part of the bidder/employees of the bidder, etc.

k. No advance payment shall be made to the agency, however quarterly payment shall be made subject to satisfactory report received from the

users.

I. The Contract shall be valid for a minimum period of one year from the date of award of the rate contract. However, the contract period shall be extendable further, subject to satisfactory services, on year to year basis

on mutually agreed Terms & Conditions.

m. The firm black listed at any point of time by any Ministry/Department need not apply. In case, the fact is concealed and it comes to the notice of the Government during the period of contract, the contract will be terminated straightway and the security deposit will be forfeited. If the fact comes to notice before award of contract his bid will be rejected outrightly.

n. If any complaint is not undertaken within a day, if the replacement of and parts/ consumable under AMC are not replaced a penalty of Rs. 200/- (Two hundred only) will be charged or part thereof for delay beyond the

two days till such time the machine is repaired.
