Interested parties should submit their bids latest by 16.12.19 before 16:00 hrs. at NSSO-DPC, 7th floor, Lilamani Corporate heights, Opp. BRTS bus stop, Vadaj, Ahmedabad. Tenders received after the stipulated date and time will not be attended. Tenders will be opened on 17.12.2019 at 11:00 hrs. in the presence of representative of the firms who wish to attend.

- 2. The Tender should be submitted in sealed cover addressed to "Head of office, NSSO-DPC, 7th Floor, Lilamani Corporate heights, Opp. BRTS Bus Stop, Vadaj, Ahmeabad super-scribing Tenders for Old, Used & Scrapped Personal Computers & Printers' on the top of the sealed envelope, indicating the firm name and full address including telephone number at the bottom of the left hand side of the envelope.
- 3. The Tenders may be sent through registered Post/Speed Post/ by hand.
- 4. Interested firms may inspect the old PCs and Printers at above-mentioned address during office hours in all working days.

6. Terms and Conditions:

- (i) Bids should remain valid for a period of 90 days from the date of opening of the bids.
- (ii) The bidders must submit a copy of the valid Registration/Authorization certificate issued by the Central/State (or Union territory) Pollution Control Board having environmentally sound management facilities for processing/handling of such Harzardous waste) failing which their tender will be liable for rejection.
- (iii) Interested bidders may quote their rates individually or as a whole and item will be disposed of as a LOT. The bid of the bidder will be rejected by the office who will not quote price of all items or as a whole.
- (iv) Tenders will be evaluated on the basis of total amount given at item Sr. no. (iii) in the table given under point 5.
- (v) Tenders should be submitted in the format given at para 5 above. Besides, tenders should be on the letter head of the firm or duly stamped by the signing authority.
- (vi) The highest bidder is required to deposit the total quoted amount in Cash or Demand Draft in favour of Head of office, NSSO (DPC), Ahmedabad
- (vii) Materials should be removed by the highest acceptable responsive (H-1) on 'AS IS WHERE IS BASIS'. Labour and transportation charges will be borne by the successful bidder.
- (viii) Successful bidder will have to lift the scrapped items before scrapping/recycling the same. Onsite scrapping/recycling will not be allowed. E-waste should be disposed off as per guidelines issued by Central /State Pollution Control board.
- Goods/materials will be allowed to be removed only during working hours. The articles will not be allowed to be removed on holidays or after working hours. The Successful bidder will have to take away all condemned listed items and not selectively.
- (x) Employees of NSSO-DPC, Ahmedabad are not eligible to take part in the bidding.
- (xi) NSSO-DPC, Ahmedabad reserves the right to accept/reject any or all tenders without assigning any reason.
