
Subject: Inviting quotations for disposal of obsolete computers, computer peripherals.



The tenderer/bidder should send the completed tender along with EMD in sealed addressed to Assistant Director & Head of Office, NSO (FOD), 1<sup>st</sup> Floor, B-block, Sanjay Complex, Jayendra Ganj, Lashkar, Gwalior – 474009, latest by 19.01.2021 up to 5.00 p.m. super scribed by "Quotation for Obsolete Computers and Computer Peripherals" in bold letters.
3. The quotation must reach the Assistant director on or before the due date otherwise it is liable to be rejected. Tender received after due date and stipulated date and time due to any reason whatsoever including postal delays shall not be considered.
4. The financial bid should be quoted both in figures and words. Any overwriting shall not be considered for acceptance of the rates offered by the tenderer.
5. This office reserves the right to accept or reject any/ all quotations without assigning any reason whatsoever.
6. Each page of the tender document should be signed by the bidder(s).
7. Incomplete and unsigned quotations are liable to be rejected.
8. An Earnest Money Deposit (EMD) of Rs. 2000/- (Rupees Two Thousand Only) must be accompanied with quotation. This shall be in the form of an account payee Demand Draft of any nationalized bank drawn in the name of the Assistant Director, NSO (FOD), Ministry of Statistics and P.I payable at Gwalior, without which the tender shall be summarily rejected. No Cheque/ money order/ cash shall be accepted.
9. The EMD deposit shall not attract any interest.
10. For Financial evaluation, highest bidder shall be chosen based on the figures quoted in Annexure 'B'.
