- (j) The contract shall normally be awarded to the lowest evaluated bidder whose bid has been found to be responsive and who is eligible/qualified to perform the contract satisfactory as per the terms and conditions incorporated in the tender notice. The Ministry reserves the option to select more than one firm for award of contract to ensure uninterrupted supply during the currency of the contract.
- (k) The tenderers whose quotation is finally accepted, shall have to furnish performance security of Rs. 100,000/- (Rupees one lakh only) in favour of P & A O, Ministry of Statistics & Programme Implementation, New Delhi by means of fixed deposit in any of the Nationalized Bank. The earnest money shall be returned to the successful bidder only after depositing performance security.
- (I) If the supplier fails to supply the water jars in the stipulated time or if the quality of the water is not as per the approved/required norms, the Department shall be free to make necessary procurement of water jars from the market at the suppliers' risk and cost which shall be recoverable from his pending bills or performance security besides resulting in cancellation of the contract. Further in case of any deficiency in service, a penalty of 5% of the total amount of the bill for the relevant period will be imposed.
- (m) The Department shall be free to test the sample of drinking water supplied by the supplier from any independent source for which all required cooperation/documentation shall be submitted by the suppliers.
- (n) Payment shall be made on monthly basis only on submission of the bill verified by the respective units/ Divisions of the Ministry for the receiving units of quantity/ jars.
- (o) Before submitting the bids by the firm, the firm should sign/ stamp on each page of the tender documents and also submit the undertaking that I (the firm) have read the terms and conditions of the tender and are acceptable to me/us. An undertaking may also be submitted with the tender that the firm is not black listed by any Ministry/ Department of the GOI.

(b) Initially the firm will be required to supply 200 bottles (20 Ltr. jar) at different locations on daily basis. The quantity of supply may be increased or decreased as per requirement of the Ministry.

(c) The firm is also required to supply 20 water dispenser (free of cost) w.e.f. the initialization of the contract. The other details of officers/ offices and place will be intimated to the firm separately. If the water dispenser is not working properly, the firm will be required to replace/ repair the same at office premises, however an arrangement will be done by the firm before replacement of the dispenser without any cost to the Ministry.

(d) In case firm is already providing the potable drinking water/maintaining the water dispensers of any other Ministry/Department of Central Government, details thereof may also be furnished along with the quotations. The rate quoted shall remain valid for the period of one year from the date of award of contract.

(e) The initial period of contract will be for two years. The contract may be extended for another year one year on the same rates and terms & conditions of the tender notice and subject to the satisfactory services rendered by the firm. The extension will be at the sole discretion of the Ministry.

(f) The supplier should be OEM (original Equipment Manufacturer) or, the firm shall submit the bids alongwith definite proof from appropriate authority as Authorized dealer (Bisleri,
