Sub:- Quotations for disposal of old and condemned four wheelers in the Ministry of Statistics & Programme Implementation.

Ministry of Statistics & Programme Implementation is proposing to dispose off the following vehicles on "as is where is basis" without guarantee, measurement, weight etc. The registration of vehicles sold through auction is not permissible with the transport department for transfer at any cost. The bidders shall be responsible for safe disposal of the vehicles as scrapes. The Details of the vehicles are as under:

2. The sealed quotation should be dropped in the Tender Box kept at the Ground Floor of Ministry of Statistics & P.I, Sardar Patel Bhawan, Sansad Marg on or before 23.02.2016 upto 3.00 p.m. which will be opened on the same day at 3.30 p.m. in Room No. 201, 2nd Floor Sardar Patel Bhawan, New Delhi by the Condemnation Committee constituted in this Ministry for the purposes. The cover should be prominently super scribed with the words "Quotation for disposal of old and condemned vehicles".

4. The disposal will be governed by the following terms and conditions:-

I The bidder is required to submit an earnest money of Rs. 10,000/- (Rupees Ten Thousand only) in the form of Demand Draft drawn on any schedule bank payable at Delhi/New Delhi in favour of Pay and Accounts Officer, Ministry of Statistics & Programme Implementation, New Delhi along with the quotation letter. Quotation received without earnest money will not be considered. Earnest money received from the tenderer will be returned to unsuccessful bidders without interest immediately after the process of selecting the awardee is over.

II. Quotation received after due date and time will not be accepted. The undersigned reserves the right to reduce or increase the number of items offered for disposal. The undersigned also reserves the right to reject any quotation or whole of the process of disposal at any time without assigning any reason. Each page of documents should be signed by the bidder(s) in token of acceptance of terms and conditions of tender. Incomplete and unsigned quotations are liable to be rejected.

III. The bidders may inspect the vehicles on all working days of third week of February, 2016 in the premises of the Sardar Patel Bhawan, New Delhi.

IV. The vehicles shall be sold to the highest price bidder who will quote the price as a whole, and the bids will be accepted of only those firms who will quote the price in all the columns of Annexure-I. No items, once disposed to the successful bidder, shall be taken back by Ministry of Statistics & Programme Implementation.

V. The successful bidder has to make the full payment in the form of Cash/Demand Draft/Pay Order of any Nationalized/Schedule Bank drawn in favour of "Pay & Account Officer, Ministry of Statistics & Programme Implementation" payable at "New Delhi" within three (3) days after confirmation, failing which the offer may be cancelled and EMD shall stand forfeited.

Vi. The EMD of the successful bidder will be released after full payment of contract is received and the vehicles are lifted from the premises of Sardar Patel Bhawan.

Vii. The successful bidder shall be required to lift the condemned vehicles from the disposal site and take away at own cost to his premises within 3 days after the payment of the quoted amount. On failure to do so, Ministry shall have the right to forfeit the entire amount of the bidder and to make disposal of the vehicles to the second highest bidder.

Viii. The vehicles may be used for scrapping and reuse for both the purposes. However, bidder has to mention the purpose of (whether to be scrapped or reused) each vehicle in Annexure – I.

ix. ~~Vii.~~ For scrapping the vehicles, successful bidder has to follow following directions:

a) A "scrapping certificate" must be submitted by the successful bidder before taking away the vehicles.

b) The vehicle identification plate (the one that has the engine and chassis numbers engraved on it, successful bidder might need someone to use a blowtorch and cut it out with surrounding metal) shall be removed and handed over to the competent authority before taking away the vehicles.

x. ~~Viii.~~ For reuse of the vehicles, successful bidder has to follow following directions:

a). The process of transfer of ownership has to be completed by the successful bidder with his own cost which should be exclusive of bid amount.


b). The vehicles will be handed over to successful bidder only after he submits the proofs and documents of transfer of ownership.

xi. ~~Vii.~~ The bidder will not be allowed to withdraw their bids. If doing so, the EMD will be forfeited.


