A. TERMS AND CONDITONS:

- The Yoga classes will be held at premises of National Academy of Statistical Administration (NASA), at Plot No. 22, Knowledge Park-II, Greater Noida (U.P), in the morning .Duration of the class will be at least one hour. The Yoga Instructor should arrive in the class room a minimum of 5-10 minutes before the start of class.
- The trainer/Yoga Instructor will be responsible to brief properly to the members /participants on safe and effective exercise techniques before commencement of the session to avoid any injury etc.
- Classes will be conducted for five days in a week preferably from Monday to Friday, it may be fixed on Saturday, if needed, and in that case one day off will be allowed, as per the requirement/convenience of NASA.
- The contract will be for one year duration which may be extended for another one year with mutual consent on the same terms and conditions, subject to providing of satisfactory service.
- The agency will be responsible to provide the suitable substitute of the engaged Yoga Instructor immediately in case the regular incumbent leaves the service or proceeded on leave or unable to take classes due to some other reasons.
- In case the services of the Yoga Instructor are found unsatisfactory by NASA the agency will replace the Instructor within 2 days, on receipt of written complaint from NASA.

- 7. The agency will liable to pay the service tax as applicable under rules.
- 8. A Demand Draft of Rs. 10,000/-(Rupees ten thousand only) drawn in favor of Pay and Accounts Officer, Min. of S&PI , New Delhi and valid for a period of six months should be enclosed with the quotation as Earnest Money Deposit (EMD) .The quotation. If received without EMD, will be rejected. The EMD will be refunded on finalization of contract without any interest.
- A lump sum payment to be made to the instructor on monthly basis should be mentioned in the quotation letter.
 - 10. There will be no increase in the rates during the contract period.
 - 11. NASA has the right to terminate the contract without assigning any reason
 - 12. Last date for receipt of quotation is 25/02/2014 up to 1500 Hours. The quotations will be opened on the same day i.e. On 25/02/2014 at 1530 Hours in the presence of the representatives of the firm, if any.

B. EDUCATIONAL QUALIFICATION/EXPERIENCE OF TRAINER

- 13. Full time study in Post Graduate Diploma in Yoga/M.A. in Yoga from a recognized university/institute.
- 14. The trainer should have minimum of 3 years experience as Yoga Instructor.

C. PAYMENT TERMS:

- 15. No advance payment will be made by the NASA. Payment will be made on monthly basis on receipt of bill.
- 16. No conveyance or the conveyance allowance will be provided/ paid to the trainer/instructor by NASA.

D. PENALTY CLAUSE: -

17. In case of any irregularities noticed the penal will be levied by NASA up to the extent of 10% of the monthly charges due for the relevant month, after issuing show cause notice to the agency and considering the explanation of the agency, if submitted with in stipulated time. Such repeated irregularities will make the agency liable for cancellation of contract with forfeiture of the Security Deposit.

E. ARBITRATION CLAUSE:-

18. In case of any disputes between the parties viz. National Academy of Statistical Administration (NASA) on one hand and the agency/firm awarded the Contract on the other hand, arising out on account of the duties assigned to the Yoga Instructor and other mandatory conditions as stated in the Tender document/ Contract Agreement, the dispute shall be referred to an Arbitrator as per Arbitration and Reconciliation Act 1996., in Delhi/Noida jurisdiction.
