

9. Tenders incomplete in any form are liable to be rejected.
10. Ministry of Statistics & Programme Implementation reserves the right to reject any or all the tenders without assigning any reason at any time
11. If any dispute(s) arises between Ministry of Statistics & Programme Implementation and the firm with reference to the Tender, decision of the competent authority in the Ministry of Statistics & PI will be final and binding upon the firm.
12. After submission of the quotations, a bidder will not be allowed to withdraw his bid for whatsoever reason(s). In case of such withdrawal, his earnest money would stand forfeited.
13. In case the successful bidder declines the offer to supply and install the DIGIBOARD at specified locations, for whatsoever reason(s), his earnest money would stand forfeited, and action as deemed fit would be initiated by the competent authority in the MOSPI.
