3. The tenders must accompany a Demand Draft/Pay Order of **Rs.5000/-**(Rupees five Thousand only) in favour of Pay & Accounts Officer, Ministry of Statistics & P.I. The Earnest Money of unsuccessful Tenderers will be returned after finalization of Tenders. The successful Tenderer will be required to deposit another **Rs.5000/-** (Rupees Five Thousand Only), in total of **Rs.10,000/-** (Rupees Ten Thousand only), as Performance Security, which will be returned without any interest after satisfactory completion of the contract period.



<u>Terms & Conditions for making Rubber Stamps, Name Plates, Banners etc.</u> <u>for the use in the Ministry of Statistics & Programme Implementation.</u>

- The firm shall be required to furnish Earnest Money Deposit (EMD) amounting to Rs.5000/- (Rupees Five Thousand Only) in the form DD/Pay order in favour of Pay & Accounts Officer, Ministry of Statistics & Programme Implementation, New Delhi along with the quotation. The successful Tenderer will be required to deposit another Rs.5000/- (Rupees Five Thousand Only), in total of Rs.10,000/- (Rupees Ten Thousand Only) as Performance Security. The EMD will be refunded to the unsuccessful tenderer after the completion of the contract.
- The schedule of requirement has been indicated in Annexure I. The firms are requested to keep in mind the economy of scale while quoting for the same. Different firms may be given different items depending upon L-1 quotation.
- The work is to be carried out in the premises of the Ministry located at Sardar Patel Bhawan, Sansad Marg, New Delhi, Jeevan Prakash Building, K.G. Marg, New Delhi and West Block, R.K. Puram, New Delhi.
- 4. It will be responsibility of the Contractor to depute a good skilled person to the Ministry of Statistics & P.I. for doing day to day work. If the person from the firm does not come to attend the job, the work will be got done by the Ministry from other sources and the cost will be recovered from the Security Deposit.
- 5. The firm should have 3 years' experience in the field. The firm should also submit copies of work contract certificate for three years working experience in Government Offices.
- 6. The firm should indicate all the relevant data mentioned in Technical specification as per **Annexure II** (legible self-attested photocopies to be enclosed).
- 7. The contract will include one visit on each working day by a responsible person for collecting the job.
- 8. No advance payment will be made. The approved contractor shall submit his bill (in triplicate) on completion of the entire job assigned to him.
- 9. The contract can be terminated by this Ministry at any time without assigning any reason, if the work of the Contractor is found unsatisfactory. In this connection, the decision of the Ministry shall be final and binding on the contractor. No payment will be made for the remaining period of service contract from the date of the termination of the contract.
- 10. This Ministry has the right to forfeit the EMD in full or in part in the event of failure on the part of contractor to fulfill the terms and conditions of the contract.



- 11. The job assigned to the firm should be completed within 2-3 days maximum. However, urgent nature work should be completed within 24 hours of its assignment or as and when needed.
- 12. If it is desired that VAT on parts is to be borne by the Government, then it should be specifically mentioned in the Tender. Otherwise, it will be presumed that the price quoted for parts is inclusive of all taxes including VAT.
- 13. The Income Tax and Education Cess, as per Government orders will be deducted on every bill submitted by the Contractor.
- 14. The finalized contract shall be interpreted under Indian Laws. In case of dispute of any kind, the firm shall abide by the decision of the Competent Authority, Ministry of Statistics & Programme Implementation, New Delhi. In case the dispute is required to be referred to Arbitration, it shall be referred to sole arbitrator under **Arbitration and Conciliation Act 1996**. The place of settlement of dispute shall be Delhi. In the case of settlement of dispute is in the court, it will be in the jurisdiction of courts at Delhi.
