
Terms and Conditions:

- 1) Firms interested in undertaking the above said work and have the capacity and competence to perform it and having minimum three years' experience, may submit quotation in a sealed envelope to the **Under Secretary, Computer Centre, East Block-10, R.K. Puram, New Delhi-110066** before 03.00 p.m. on **26.10.2012**. The tenders will be opened at 03.30 p.m. on the same day in the presence of the representatives of intending tenderers who are present. Every intending tenderer has to sign the conditions of tender in token of having accepted the same.
- 2) All intending tenderers will have to furnish an Earnest Money Deposit of Rs.2000/- in the form of Demand Draft in favour of "Pay & Accounts Office, Ministry of Statistics &

Programme Implementation" along with the tender. The tender without earnest Money Deposit will not be considered.

- 3) The tenderer will furnish the details of Ministries/Departments/PSUs where similar work is undertaken in the last two years.
- 4) The Earnest Money Deposit will be refunded within two weeks of finalization of the contract to all those, whose offer have not been accepted.
- 5) The successful tenderer shall enter into an agreement with this Centre for the period of CAMC.
- 6) The payment to the firm will be made on quarterly basis, through ECS at the end of each quarter against invoice/bill with PAN number, raised by the firm and based on past performance.
- 7) The taxes, if any should be clearly mentioned, otherwise the rate quoted shall be taken as inclusive of taxes.
- 8) If the date of tender happens to be holiday, the tender will be opened on the next working day at the same time and place.
- 9) The tenderer agrees that time/period wherever specified in the tender is the essence of the contract.
- 10) Any dispute arising out of this tender shall be settled in the court of law within the jurisdiction of NCT of Delhi.
