

1. Parties:

Bids received without super-scribing as above or received after the due date & time shall not be accepted.
4. The materials can be inspected on any working day between 11.00 hrs. to 16.00 hrs. at the office premises.
5. Transportation/ labour charges etc. shall be borne by the successful bidder.
6. Bidder shall quote their offer price for the whole material as per the format given in Annexure –II.
7. The total sale value has to be deposited in the form of Demand Draft in favour of 'PAO, MOSPI, Kolkata' before lifting the material from the office.
7. This office reserves the right to accept or reject any quotation without assigning any reasons.
8. No employee of this office or his/her family member can participate in this tender.
9. Tender Availability & Earnest Money Deposit (EMD):
- The tender documents can be downloaded from the website <https://eprocure.gov.in> or <http://mospi.gov.in/>.
 - Earnest Money Deposit of **Rs 10,000/-** (Rupees Ten Thousand) only must be deposited by the tenderers through Demand Draft in favour of '**PAO, MOSPI, Kolkata**'.
 - EMD of the unsuccessful bidders will be returned without interest after the sale is awarded to the successful bidder. The EM
 - EMD of the successful bidder will be adjusted with the sale proceed.
 - Tenderer shall not be permitted to withdraw his/her offer or modify the terms and conditions thereof. In case the tenderer fails to observe and comply with the stipulations made herein or backs out after quoting the rates, the aforesaid amount of earnest money shall be forfeited to the Government.

The representative attending the opening of the tender on behalf of the tenderer should bring with him a letter of authority from the tenderer and a proof of identification on the date and time indicated in the "Schedule of Tender". If the tender could not be opened at the given time and date due to unforeseen circumstances, the same will be intimated on the change in scheduled date & time.

12. Criterion for Evaluation of Tenders:

The price quoted by the highest bidder shall be declared as the successful bidder.

13. Time period for lifting of materials:

The successful bidder shall lift the material from the office within the stipulated time period as communicated by the office, otherwise the offer will be rejected & tender will be cancelled, resulting in forfeiting of the EMD.


